(Revenue \$) Grants to Families: Through this program we provide one-time emergency grants for expenses such as rent/mortgage, utilities, groceries and transportation. The average grant is \$1,200. In FY 2013, we provided aid to 314 clients through this program. In some circumstances we provide assistance for non-emergency needs. In FY 2013, this program helped 11 service members and veterans, including a veteran who had lost both legs and could not afford the kind of mattress he needed.

4b (Code:) (Expenses \$ 121,045. including grants of \$ 61,696.) (Revenue \$) Energy Assistance Fund: Pays utility bills for veterans and military families through grants from Energy Outreach Colorado, augmented by our general fund.

4c (Code:) (Expenses \$ 11,616. including grants of \$) (Revenue \$) Welcome Home Heroes Fund: An important morale-builder that shows returning soldiers that their community welcomes and appreciates them. Volunteers from THFC meet every plane that arrives in Colorado Springs carrying soldiers returning from Iraq and Afghanistan. We hand each service member a donated cheeseburger and soda, greet them and thank them for their service. In FY 2013, 130 volunteers greeted almost 4,500 returning service members. The WHH Fund also helps family members attend memorial services (15 families in FY 2013). Help Line: Our help line enables us to direct those who need and qualify for our assistance to one of our referring partners and to connect other veterans to more suitable resources. In FY 2013, our help line assisted 862 service members and veterans.
