1 Briefly describe the organization's mission: The Home Front Cares serves the entire state of Colorado providing emergency and responsive support for Colorado service members, veterans and military families who have been impacted by deployment in harms way.

4a (Code: ) (Expenses \$ 556,571. including grants of \$ 351,389. ) (Revenue \$ ) Grants to Families: Through this program we provide one-time emergency grants for expenses such as rent/mortgage, utilities, groceries and transportation. The average grant is \$1,268. In FY 2016, we provided aid to 315 clients through this program in the amount of \$399,549. 69% of clients served have children in their homes and 75% of clients served self-identified as having a disability.

4b (Code: ) (Expenses \$ 115,787. including grants of \$ 49,459. ) (Revenue \$ ) Energy Assistance Fund: Pays utility bills for veterans and military families through grants from Energy Outreach Colorado, augmented by our general fund.

4c (Code: ) (Expenses \$ 5,316. including grants of \$ 6,080. ) (Revenue \$ ) Welcome Home Heroes Fund: Volunteers from THFC meet every plane that arrives in Colorado Springs carrying soldiers returning from Iraq and Afghanistan. We hand each service member a donated cheeseburger and soda, greet them and thank them for their service. In FY 2016, 100 volunteers greeted 23 returning flights with 4,000 returning service members. Help Line: Our help line enables us to direct those who need and qualify for our assistance to one of our referring partners and to connect other veterans to more suitable resources. In FY 2016, we helped 1,255 service members and veterans in the latter category. In some circumstances we provide assistance for non-emergency needs. In FY 2016, this program supported 12 service members and veterans and their families with \$6,080 in grant support.
